The District Level Family Engagement Plan aims to support and strengthen the partnership between the school, students, and home. This plan has been developed jointly with parents/families. It is aligned with Board of Education Policy ABC, Parent and Family Involvement, and the Montgomery County Public Schools (MCPS) Strategic Plan. In this plan, 'parent' is intended to include parents, guardians, caretakers, and other family members involved in supervising the child's schooling. Suggestions are provided to revise the plan and create opportunities for increased family engagement.</li> <li>★ Developing the School-Level Parent and Family Engagement Plan at each Title I school by using a template that includes the necessary Title I program requirements.</li> <li>★ Schools annually analyze and revise their School-Level Parent and Family Engagement Plan at their Family Engagement committee meetings and leadership meetings.</li> </ul>

<p><b>Parent Academy TO GO:</b> The MCPS “Parent Academy TO GO,” a series of virtual presentations for families with information central to their children’s academic and emotional well-being. Workshops are provided to families at least twice a month during the school year on a variety of topics such as:</p> <ul style="list-style-type: none"> <li>★ understanding the State academic standards, State and local academic assessments, and how to monitor a child’s progress,</li> <li>★ supporting the development of their child’s physical, social, and psychological well-being;</li> <li>★ working with educators to improve student achievement, and helping parents work with their children.</li> </ul> <hr/> <p><b>Family Workshops:</b> Title I instructional specialists provide materials and training to parents/families and school staff members at each school translated and/or interpreted based on community needs on:</p> <ul style="list-style-type: none"> <li>★ understanding Title I requirements</li> <li>★ enhancing communication, collaboration, and outreach between home and school</li> <li>★ supporting their children’s academic progress at home</li> </ul> <hr/> <p><b>School Parent/Family Engagement Processes:</b> Title I Instructional specialists support schools and families by:</p> <ul style="list-style-type: none"> <li>★ providing resources and training to teachers in Title I schools on best practices for having effective communication, collaboration, and engagement with families.</li> <li>★ providing resources and training for families to engage in successful parent-teacher partnerships.</li> <li>★ working with Family Engagement Committees in their quarterly meetings to ensure that parents/families have the opportunity to collaborate and make decisions about how family involvement funds are spent.</li> </ul>	<p><b>Staff Training:</b> Technical assistance is provided throughout the year by Title I Instructional Specialists through a variety of forums and on an array of topics related to their work as members of central office staff and school-based staff members. Support provided to schools includes but is not limited to:</p> <ul style="list-style-type: none"> <li>★ Developing school-parent/family compact and school-level Family and Parent Engagement Plan.</li> <li>★ Planning and developing professional learning for school staff members to work as equal partners and collaborators with parents/families</li> <li>★ Communicating and collaborating with families as equal partners in their children’s education.</li> <li>★ Providing training with the Family Engagement Specialist to school-level Parent Community Coordinators.</li> <li>★ Connecting school-level Parent Community Coordinators with resources and community-based organizations to increase parent and family engagement.</li> </ul> <hr/> <p><b>Instructional Specialist Training:</b> Title I instructional specialists communicate, coordinate, and collaborate to ensure compliance with federal and state requirements. Title I staff members will also receive training on relevant issues, which they will share with school staff members and families, including but not limited to:</p> <ul style="list-style-type: none"> <li>★ Evidence-based strategies for parent and family engagement</li> <li>★ Preparation, training, and monitoring of family involvement budgets</li> <li>★ Coordinating collaboration of parents/families in family involvement budget decisions</li> <li>★ Appropriate use of federal funds for family engagement initiatives and efforts by Title I schools</li> </ul>
Support to Schools	Coordination to Schools
<p>The Department of Early Childhood, Federal, and Special Programs (DECFSP) communicates, coordinates, and collaborates in family engagement initiatives with MCPS offices by:</p> <ul style="list-style-type: none"> <li>★ Actively participating on various committees throughout the year.</li> <li>★ Meeting and planning with the Division of Specialized Support Services and Parent Community Coordinators to support outreach and training efforts for Title I parents/families.</li> <li>★ Partnering with Prekindergarten/Head Start to coordinate training efforts for Title I parents/families to ensure a streamlined approach to increasing family engagement.</li> </ul>	<p>The coordination of Title I parent and family engagement efforts and technical assistance to Title I schools will be provided by Title I instructional specialists from DECFSP. Title I instructional specialists provide:</p> <ul style="list-style-type: none"> <li>★ Support, guidance, and assistance to school staff members in planning and implementing effective family engagement experiences to improve student achievement and school performance.</li> <li>★ Assistance with developing the School-Parent/Family Compact, School-Level Plan, and other parent/family engagement opportunities.</li> <li>★ Documentation that demonstrates adherence to Title I, part A federal and state requirements and will be maintained at DECFSP.</li> </ul>
